<p>The City of Laurinburg's fees for the pickup of bulky items or yard waste from customers using bulk containers shall be the amount to cover all costs incurred by the City to remove such waste, which shall include tipping fees, labor costs, and equipment costs. When these costs cannot be readily determined, the fee shall be a flat rate of \$35.00 for each occurrence that collection services are rendered. In lieu of paying for this service on a per pickup basis, bulk container customers may also be given the option, upon request, of paying a set monthly rate of \$35.00 per month to receive this service on a regular basis in accordance with the City's Solid Waste Policy, if approved by the Sanitation Department. These fees will be added to the customer's monthly utility bill, if applicable, in addition to any fees for other services provided by the City.</p>							
<p>The City of Laurinburg's fees charged for fish market collection shall be \$47.00 per month in addition to any charge for dumpster services or other services provided by the City. This fee will be added to the customer's monthly utility bill, if applicable.</p>							
<p>The City of Laurinburg's fees charged for any other service not covered by a specific fee in the schedule of fees will be the amount to cover all costs incurred by the City to provide that service, which shall include tipping fees, labor costs, equipment costs, and overhead costs. When these costs cannot be readily determined, the fee shall be a flat rate of \$35.00 for each occurrence that collection services are rendered. Other services shall include, but not be limited to, the abatement of violations of the solid waste ordinance by the City. These fees will be added to the customer's monthly utility bill, if applicable, in addition to any fees for other services provided by the City.</p>							
<p><b>CIVIL PENALTIES*-The minimum civil penalties for violation of the Garbage and Refuse Ordinance and/or the Solid Waste Policy are as follows:</b></p>
